As a strategic partner, the EU seeks to enhance cooperation with Africa to promote actions targeted to finding locally adapted solutions to challenges that are global in nature, but which often hit Africa hardest.

The <u>Comprehensive Strategy with Africa</u>, the <u>Global Approach to Research and Innovation</u> and the <u>Global</u> <u>Gateway</u> are the EU's most recent policy initiatives that prioritise Research and Innovation (R&I) as a key dimension of sustainable development.

The African Union – European Union High Level Policy Dialogue (<u>HLPD</u>) on Science, Technology and Innovation (STI) is the policy forum where regular exchanges on R&I policy take place between both continents and where long-term priorities to strengthen cooperation are decided.

Horizon Europe and the Africa Initiatives

The Africa Initiative I and Africa Initiative II are, respectively, part of the first two Work Programmes of Horizon Europe (2021-22 and 2023-24, respectively) and comprise sets of calls for proposals requiring or encouraging participation of African entities. Topics support the implementation of the four jointly identified policy priorities for AU-EU R&I cooperation and range from climate change, rural innovation, sustainable food systems and sustainable energy to bringing highly innovative European SMEs to African markets and support the development and enhancement of resilient value chains. An Africa Initiative I was launched in 2021 with 36 topics and €350 million, under which so far 126 grants have been signed and 181 eligible proposals retained with participation of African partners. An Africa Initiative II was launched in 2022 with 27 topics and €300 million under which so far 255 proposals have been received with participation of partners from 42 African countries.

Bilateral Science and Technology agreements

The EU has <u>bilateral agreements</u> with 20 individual countries around the world. These agreements are based on common interests and priorities, aiming to increase cooperation in R&I. In Africa, these countries currently are: Algeria, Egypt, Morocco, South Africa and Tunisia. Morocco is a Horizon Europe candidate associated country, while Tunisia has successfully completed the formal negotiations allowing it to become associated to Horizon Europe.

What's next? The joint AU-EU Innovation Agenda and its implementation

The EU and the AU have jointly developed the <u>AU-EU Innovation Agenda</u>, supported by the Global Gateway, to transform and increase the innovative capacities and achievements of European and African researchers and innovators into tangible outputs, supporting sustainable growth and jobs.

Several instruments and initiatives are being devised and will be put in place to implement the AU-EU Innovation Agenda, including, among others, Horizon Europe, the Global Health European and Developing Countries Clinical Trials Partnership 3 (EDCTP3) Joint Undertaking, and initiatives part of the Global Gateway Africa-Europe Investment Package as well as under the Team Europe approach.

<u>ENRICH in Africa</u> is a Horizon 2020 project that aims to strengthen and connect innovation ecosystems in Africa and Europe, to upgrade the capacity of incubators and accelerators and benefit entrepreneurs in both regions. The <u>ENRICH in Africa virtual community</u> platform includes 439 members, 293 of whom being companies (64% from Africa and 26% from Europe), 86 investors and 60 business support organisations, such as incubators and accelerators. The project has led to the opening of the ENRICH in Africa Center. Based in Cape Town, South Africa, the Center aims to become the go-to platform for innovators, incubators, accelerators, investors, businesses and policymakers looking to strengthen the EU-African tech and innovation ecosystems.

Follow what's new, engage and seize opportunities on the AU-EU Innovation Agenda through the new <u>AU-EU Innovation Interface</u>! Part of the <u>Innovation Talent Platform</u>, the AU-EU Innovation Interface will provide information on initiatives and opportunities for innovators, entrepreneurs, researchers and investors during the implementation of the AU-EU Innovation Agenda. Among other resources, this Interface will give access to a new "**AU-EU Deep Tech Transformation Training Scheme**", addressed to innovators and entrepreneurs, starting before the end of 2023! The Interface will be constantly updated throughout the implementation timeframe of the AU-EU Innovation Agenda.

Established in 2021, the Global Health European and Developing Countries Clinical Trials Partnership 3 (Global Health EDCTP3) Joint Undertaking has a total budget of €1.6 billion and works to deliver new solutions to reduce the burden of infectious diseases in sub-Saharan Africa and to strengthen research capacities. The Global Health EDCTP3 Work Programme for 2023 has over €130 million in funding opportunities to support research into vaccines, treatments and diagnostics, among others. Deadline to apply for the second call for proposal is set for 28 September 2023.
