
Key Information on EIC Accelerator last call (20 March) – Submission step

- An exceptional cut-off of records due to COVID crisis:
 - Highest number of submitted applications: 3,969 out of which 3,883 eligible applications (+110% of increase, mainly due to COVID related applications (see below) but non only (increase of 33% without COVID related applications));
 - Highest aggregated requested financial support: more than EUR 10 billion;
 - Highest number of participating countries: 45 countries (all 27 MS + UK + 13 H2020 AC + 3 OCT + GI);
 - Record number of COVID related eligible applications: 1,418, submitted from 42 countries (all 27 MS + OK + 11 H2020 AC + 2 OCT + GI) calling for an aggregated financial support of more than EUR 2.6 billion (see A1.4 for more details);
 - Highest participation of startups and SMEs located in Horizon 2020 Widening countries: 11.6% of the eligible applications (even reaching 14% of the eligible COVID related applications).

Key Information on COVID related applications in EIC Accelerator last call – Submission step

- A bottom-up call but Commission encouraged submission of COVID applications. As a result an exceptional number of **COVID** related applications:
 - **1,418** eligible applications (36.5%) from 42 different countries;
 - An aggregated requested financial support of more than **EUR 2.6 billion** (26.1%);
- A portfolio of eligible applications of a different nature than in previous cut-offs or in current cut-off NON COVID related applications (1):
 - A lower but still important presence of blended finance applications:
 - 19.0% of all eligible applications (269);
 - 50.3% of the aggregated requested financial support (EUR 1.32 billion).
 - A stronger presence of grants requests, with a lower but still important domination of grants with consent applications:
 - 81.0% of all eligible applications, out which 71.5% are grant with consent applications (822 grants with consent; 327 grants only)
 - √ 49.7% of the aggregated requested financial support (EUR 0.96 billion for grants with consent; EUR 0.34 billion for grants only).






Share of eligible applications per type of financial requests



Breakdown of eligible applications: COVID related vs other applications (in %)




type of COVID related eligible applications and type of financial support


Aggregated number of COVID related eligible applications per country (in decreasing order)
