2ND EOSC SUMMIT: FROM VISION TO IMPLEMENTATION

Abstract: The EOSC Summit 2018 will take place with the support of the EOSC High Level Expert Group and of the FAIR Data Expert Group, that are both advising the Commission on the way forward with the implementation of the European Open Science Cloud (EOSC). Participation will be by invitation only, primarily targeting the members of the 'coalition of doers' that emerged from the successful first EOSC Summit held in June 2017 and the wide support to the ensuing EOSC Declaration.

The aim of the EOSC Summit 2018 will be to take stock on progress and achievements towards the EOSC, a year on since the 2017 Summit. It will allow participants to share information on relevant activities and commitments and to reflect on the steps ahead to ensure an effective implementation of the EOSC. It will also serve as an opportunity to launch a stakeholder consultation on the draft 'Rules of Participation of EOSC' and on the draft 'FAIR Data Action Plan', two key inputs for the future EOSC governance.
