



## **CALL FOR EXPRESSION OF INTEREST FOR THE SELECTION OF MEMBERS OF THE STAKEHOLDERS GROUP OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING**

### **1. Background**

The Global Health EDCTP3 Joint Undertaking (GLOBAL HEALTH EDCTP3 JU) is a partnership between the European Union and the European and Developing Countries Clinical Trials Partnership (EDCTP) Association whose members are several EU Member States and Associated countries and several African countries. The Global Health EDCTP3 JU is established by Council Regulation (EU) 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe<sup>1</sup>. It aims at supporting clinical research to deliver solutions to reduce the burden of infectious diseases in sub-Saharan Africa and strengthen research capacities to prepare and respond to emerging infectious diseases.

The first and second European and Developing Countries Clinical Trials Partnership (EDCTP) programmes<sup>2,3</sup> represent since 2003 a flagship for conducting sound multi-country clinical trials in sub-Saharan Africa, building a true partnership between Europe and Africa, and fostering African leadership in scientific research. These programmes have also contributed to improving linkages between African researchers and African research organisations, which resulted in the launch of four African Regional Networks of Excellence for clinical trials. Moreover, they have strengthened the ethics review capacity and national regulatory authorities in many African countries and contributed to establish relevant organisations in the region.

Building on the positive experience of the previous EDCTP programmes, the Global Health EDCTP3 JU intends to:

- (a) Reduce the socio-economic burden of infectious diseases in sub-Saharan Africa by promoting the development and uptake of new or improved health technologies;
- (b) Increase health security in sub-Saharan Africa and globally by strengthening the research and innovation-based capacities for preparedness and response to control infectious diseases.

Global Health EDCTP3 JU is established until 31 December 2031. During the initial period until the Joint Undertaking has reached autonomy the operations are managed by the European Commission.

The governance of the Global Health EDCTP3 JU is led by a Governing Board, in which both the EDCTP Association and the European Commission, representing the Union, have equal votes. The implementation of the programme is ensured by a programme office under the lead of an Executive Director. The Global Health EDCTP3 JU is to be advised by a Scientific Committee and a Stakeholders Group.

The Stakeholders Group of the Global Health EDCTP3 JU has the following tasks:

- (a) provide input on the scientific, strategic and the technological priorities to be addressed by the Global Health EDCTP3 Joint Undertaking as laid down in the Strategic Research and Innovation Agenda or any other equivalent document taking account the progress and needs of the Global Health and adjacent sectors;
- (b) provide suggestions to enable concrete synergies to take place between the Global Health EDCTP3 Joint Undertaking and the adjacent sectors or any sector with which synergies will be deemed of added value;
- (c) provide input to the EDCTP Forum.

## **2. Composition of the group**

The Stakeholders Group is open to all public and private stakeholders, including organised groups, active in the field of the Global Health EDCTP3 Joint Undertaking, international interest groups from the Member States, associated countries and other countries.

The Stakeholders Group shall have a balanced representation of stakeholders from a geographic, thematic and gender perspective, including in particular African expertise.

Following a prior call for Expressions of Interest, the Governing Board has appointed ten members. This new call is launched to broaden the expertise of the group. The Global Health EDCTP3 JU may also reach out to stakeholder organisations to invite them to submit candidatures through this call for Expression of Interest.

## **3. Appointment**

The Governing Board of the Global Health EDCTP3 JU shall appoint the members of the Stakeholders Group for a two-year period. They shall remain in office until replaced or until the end of their term of office, whichever is earlier. Upon recommendation by the Executive Director, the Governing Board may decide to renew the appointment for an additional period of two years.

The approved reserve list shall be valid for the duration of the term, including any subsequent renewal, of the appointed Stakeholders Group. In case of a vacancy, the Governing Board shall, subject to continuing eligibility in terms of the criteria presented in section 5, select a new member from the reserve list for a period of two years or for the rest of the duration of the term of the Stakeholders Group, whichever is the shortest.

#### **4. Rules of engagement and operation of the Stakeholders Group**

The Stakeholders Group will elect its chair from among its members.

The Stakeholders Group will meet at least once a year in Global Health EDCTP3 JU premises or virtually depending on the circumstances. Meetings are convened by the Executive Director of the Global Health EDCTP3 JU. In addition to the Members, the meetings will be attended, as required, by the Executive Director or his or her representative as well as a limited number of staff members of the Global Health EDCTP3 JU programme office ensuring the secretariat of the Stakeholders Group.

Minutes of meetings of the Stakeholders Group will be drafted by the GH EDCTP3 JU programme office and will be reviewed by the Chairperson and the Members. Following formal approval by the Stakeholders Group, the minutes will be published on the website of the GH EDCTP3 JU.

The Stakeholders Group will be regularly informed of the activities of the GH EDCTP3 JU and will be invited to provide comments on its planned activities.

Meetings will be conducted in English and documents will be drafted in English.

The Global Health EDCTP3 JU programme office will provide secretarial services to the Stakeholders Group.

The members of the Stakeholders Group will be subject to the obligation of professional secrecy which, by virtue of the Treaties and the rules implementing them, applies to all members of the institutions and their staff, as well as to the Commission's rules on security regarding the protection of sensitive non-classified and Union classified information, laid down in Commission Decisions (EU, Euratom) 2015/443(31) and (EU, Euratom) 2015/444(32), respectively.

Before appointment, all members of the Stakeholders Group shall be required to complete a declaration of confidentiality as well as a commitment to disclose any actual or potential conflict of interest according to the procedure established by the Governing Board to give effect to Articles 33 and 42 of the Council Regulation 2021/2085 establishing the Joint Undertakings under Horizon Europe.

The same rules on appointment, reimbursement of costs and allowances, applicable to external experts according to the rules of the European Commission shall apply to the members of the Stakeholders Group.

## 5. Application procedure.

Interested individuals on behalf of a stakeholder are invited to submit their application to the Global Health EDCTP3 Joint Undertaking via the functional mailbox:

The Global Health EDCTP3 JU may also reach out to stakeholder organisations to invite them to submit candidatures through this call for Expression of Interest.

Applications must be completed in one of the official languages of the European Union. However, applications in English would facilitate the evaluation procedure. If another language is used, it would be helpful to include a summary of the application in English.

An application will be deemed admissible only if it is sent by the deadline and includes:

- A cover letter confirming the candidate's representation of a stakeholder **and** explaining the candidate's motivation for applying and how the applicant fulfills the criteria set out below.
- A *curriculum vitae* (CV)

### Deadline for applications

The duly signed applications must be sent by 11 June 2023 23:59:00 hrs Brussels time (CEST) at the latest to the following e-mail address:

### Selection criteria

The Governing Board of the Global Health EDCTP3 JU will take the following criteria into account when assessing applications:

Candidate Members of the Stakeholders Group shall meet the following essential eligibility criteria:

- Have at least five years of professional experience in a relevant scientific area.

Candidate Members of the Stakeholders Group shall meet the following specific selection criteria:

- (a) Representing a stakeholder and having expertise or working in one of the following areas:
  - Patient organizations;
  - Civil society in global health, in particular as regards infectious diseases in sub-Saharan Africa;

- Professional international and regional organizations active in the areas of global health, especially infectious diseases in sub-Saharan Africa;
- Local or regional government representatives providing health services in sub-Saharan Africa and addressing infectious diseases;
- Social entrepreneurs and product development partnerships developing solutions for issues in global health, especially infectious diseases in sub-Saharan Africa;
- Businesses/industry/SMEs including eHealth and data scientists working in the area of global health, especially infectious diseases in sub-Saharan Africa;
- Research institutions addressing infectious diseases affecting sub-Saharan Africa;
- Other funders of Global Health research with a focus on low and middle income countries.

(b) Very good command of written and spoken English.

In addition, a record of previous participation in other scientific and/or technological advisory bodies, demonstrating the ability to look for consensus and to provide synthetic, wide-spectrum analyses would be considered an asset.

European Commission staff, including external staff working for the Commission, staff of the Joint Research Centre, and officials of Member States shall not be eligible.

Persons who are employed by the EDCTP Association, by a country that is member of the EDCTP Association or who are employed directly by the Joint Undertaking shall not be eligible.

#### Selection procedure

The selection procedure shall consist of an assessment of all applications against the admissibility and the essential eligibility criteria. The Executive Director shall prepare a list of all candidates eligible to become members of the Stakeholders Group based on the essential criteria.

An evaluation panel composed of a given number of members shall carry out an objective assessment of the eligible candidates on the basis of all the specific selection criteria set out in the previous section.

In its assessment, the Governing Board shall take into account:

- The competencies and expertise that are necessary to provide input on the scientific, strategic and technological priorities to be addressed by the Global Health EDCTP3 Joint Undertaking
- The need to reflect a balanced stakeholder representation from a geographic, thematic and gender perspective, including in particular African expertise. As far as possible, the Global Health EDCTP3 Stakeholders Group should be balanced in terms of North-South representation with preference for European and African stakeholders.

The Governing Board shall establish a shortlist of up to twenty-five (25) candidates who are considered best suited for appointment as well as a reserve list of up to twenty (20) candidates.

The Chair of the Governing Board shall present the results of the evaluation panel's selection process to the Governing Board, including a full record of the candidates not included in the lists mentioned above as well as of the candidates whose applications were deemed inadmissible or ineligible by the Executive Director. Based on the lists established by the evaluation panel, the Governing Board shall appoint the Members of the Stakeholders Group and approve the reserve list.

The candidate members shall be required to inform the Global Health EDCTP3 Joint Undertaking immediately of any changes to their administrative and technical details, which would result in a change to their original application.

## **1. Introduction**

The European Commission, being responsible for the establishment and initial operation of the Global Health EDCTP3 Joint Undertaking (hereafter ‘GH EDCTP3 JU’) is committed to protect your personal data and to respect your privacy. The European Commission collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reasons for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, of the Data Protection Officer and of the European Data Protection Supervisor.

This privacy statement concerns the following processing operations:

- (1) *“Selection of members of the Stakeholders Group and selection of members of the Scientific Committee of the Global Health EDCTP3 Joint Undertaking”* undertaken by the Commission department which is responsible for the establishment and initial operation of the GH EDCTP3 JU before autonomy of the Joint Undertaking and which is the Data Controller for the selection process (DG RTD, unit D.1), and
- (2) *“Publication the names of members of Governance Bodies of the Global Health EDCTP3 Joint Undertaking on the Joint Undertaking’s website”* undertaken by the same department.

The selection of members of the Stakeholders Group and of members of the Scientific Committee are carried out via a public call for expressions of interest.

The Global Health EDCTP3 Joint Undertaking intends to demonstrate a high level of transparency of its activities and operations. This includes publishing on its website the names of individuals serving on the different governance bodies, including the members of the Stakeholders Group and of the Scientific Committee.



## **2. Why and how do we process your personal data?**

### Purpose of the processing operations:

The Data Controller collects and uses your personal data to manage the GH EDCTP3 JU Stakeholders Group and the Scientific Committee, in particular by selecting its members, and to ensure transparency on the Stakeholders' Group and the Scientific Committee's membership and activities. In that context, in order to select among the applicants who best fulfil the selection criteria mentioned in the respective calls for expressions of interest, Commission services collect and assess personal information of candidate members of the Stakeholders Group and Scientific Committee, respectively.

For candidates, personal data is stored by the Commission service managing the Stakeholders Group and Scientific Committee. Some types of personal data of the appointed members of the Stakeholders Group and the Scientific Committee are made publicly available on the website of the GH EDCTP3 JU, alongside similar information about members of the other governance bodies of the Joint Undertaking.

Your personal data will not be used for an automated decision-making including profiling.

## **3. On what legal ground(s) do we process your personal data**

We process your personal data, because processing is necessary for the performance of a task carried out in the public interest (Article 5(1) (a) of Regulation (EU) 2018/1725), since it allows for the selection of members of expert groups (individuals appointed as members in a personal capacity, individuals appointed to represent a common interest and organisations) and also increases the transparency on expert groups.

Processing is also necessary to comply with a legal obligation to which the controller is subject (Article 5(1) (b) of Regulation (EU) 2018/1725). The Union act for such necessary processing under Article 5(1)(a) and (b) of Regulation (EU) 2018/1725 is Council Regulation (EU) 2021/2085 of 19 November 2021 **establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014** and in particular Articles 21(4) and 22(3) thereof.

## **4. Which personal data do we collect and further process?**

In order to carry out these processing operations, the Data Controller may collect the following categories of personal data:

*Name;*

*Function;*

*Contact details (for example, e-mail address, telephone number, mobile telephone number, fax number, postal address, company or university or research institution and department, country of residence, IP address);*

*Information for the evaluation of selection criteria or eligibility criteria (for example, expertise, technical skills and languages, educational background, professional experience, including details on current and past employment);*

*Nationality;*

*Gender.*

The provision to the Commission service of the personal data required is mandatory to meet a legal requirement of selecting members of the Stakeholders Group and the Scientific Committee as set in Council Regulation 2021/2085. In principle, the types of personal data listed above (with the exception of contact details and information for the evaluation of selection criteria or eligibility criteria) are made publicly available on the website of the Global Health EDCTP3 Joint Undertaking to ensure transparency on the composition and functioning of the GH EDCTP3 JU governance bodies. If you do not provide the personal data required, possible consequences are that you will not be considered for selection as a member of the GH EDCTP3 JU Stakeholders Group or the Scientific Committee or, if already selected, your membership will be suspended.

#### **5. How long do we keep your personal data?**

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing. The following modalities apply:

The competent Commission services keep personal data submitted to them as part of rejected applications for maximum 3 years after the end of the selection process and do not process them for other purposes; these personal data are not published.

The members of the Stakeholders Group, the Scientific Committee and the other governance bodies of the GH EDCTP3 JU and some types of personal data, as described in Heading 4, are published on the website of the GH EDCTP3 JU during the duration of existence of the respective governance bodies.

When an individual is no longer member of the Stakeholders Group, the Scientific Committee or one of the other governance bodies, all personal data related to this individual, is removed from the website and is therefore not public anymore.

The competent Commission services keep personal data for the period during which the relevant individual is a member of the Stakeholders Group, the Scientific Committee or other governance body of the GH EDCTP3 JU and for 5 years after the date on which the individual is no longer member.

#### **6. How do we protect and safeguard your personal data?**

Personal data submitted in paper form is stored in the competent Commission service. All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.)

are stored on the servers of the Commission. All processing operations are carried out pursuant to the [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

## **7. Who has access to your personal data and to whom is it disclosed?**

Access to your personal data collected in the course of the process of selection of members of the GH EDCTP3 JU Stakeholders Group or the Scientific Committee is provided to the Commission staff authorised for carrying out this processing operation and to other authorised Commission staff according to the “need to know” principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

Access to personal data is also provided to the members of the Governing Board or their representatives who are involved in the selection of members of the GH EDCTP3 JU Stakeholders Group or the Scientific Committee. Members of the Governing Board or their representatives are bound by the Rules of Procedure of the Governing Board to confidentiality of all its proceedings and sign a declaration of confidentiality and of conflict of interest to this effect.

Certain personal data collected, as explained in Headings 4 and 5, is made publicly available on the website of the GH EDCTP3 JU.

Please note that pursuant to Article 3(13) of Regulation (EU) 2018/1725, public authorities (e.g. Court of Auditors, EU Court of Justice) which may receive personal data in the framework of a particular inquiry in accordance with Union or Member State law shall not be regarded as recipients. The further processing of those data by those public authorities shall be in compliance with the applicable data protection rules according to the purposes of the processing.

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

## **8. What are your rights and how can you exercise them?**

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access your personal data and to rectify them in case your personal data is inaccurate or incomplete. Under certain conditions, you have the right to

erase your personal data, to restrict the processing of your personal data, to object to the processing and the right to data portability.

You have the right to object to the processing of your personal data on grounds relating to your particular situation in accordance with Article 23(1) of Regulation (EU) 2018/1725.

Only as regards the publication of your name on the website of the Global Health EDCTP3 Joint Undertaking, you may submit a request to the competent Commission service for a derogation where justified on compelling legitimate grounds in relation to your specific situation (such as the case where the publication of your name on the website of the Global Health EDCTP3 Joint Undertaking could endanger your security or integrity).

You can exercise your rights by contacting the Data Controller or, in case of conflict, the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under Heading 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under Heading 10 below) in your request.

Any request for access to personal data will be handled within one month. Any other request mentioned above will be addressed within 15 working days.
