Scope: The event is part of the consultation process for the development of the European Water Resilience Strategy. Commissioner Roswall will be present to welcome participants and give an opening statement. The event will include sessions on the main aspects of the water resilience agenda, including governance and implementation, industry, research and innovation, and the international dimension. Participating stakeholders will be asked to give their contribution and engage in active discussions on the spot. The event will also discuss the innovative solutions offered by the Mission and research and innovation from source-to-sea. It will showcase research and innovation solutions to for restoring rivers, lakes and coastal waters and strengthen water resilience of communities across Europe.

The WRS event is also part of a week-long series of events centred around the "Mission Restore our Ocean and Waters Forum 2025," with its third annual forum focused on the Mission's objectives. The forum will highlight the extensive mobilization and specific research and innovation solutions developed to support the Mission's goals. It aims to review and celebrate achievements by 2025, engage the participating community, and discuss necessary future steps to reach the 2030 targets. The forum will cover topics such as protecting and restoring ecosystems, eliminating pollution, achieving climate neutrality and circularity, and securing funding for deployment and scaling efforts.

During the WRS event the 'Sustainable Rivers & Lakes Awards' will be awarded to three winners, one for each category in: 'Governance', 'Innovation', and 'Restoration' selected from 41 nominations coming from all four Mission Ocean & Waters area based lighthouses: 1) Atlantic-Arctic, 2) Mediterranean Sea, 3) Baltic-North Sea, and 4) Danube-Black Sea. Mission lighthouses are sites to pilot, demonstrate, develop and deploy Mission activities across EU seas and river basins.

Targeted stakeholders: Key stakeholders involved include Member States and Associated Countries, relevant third countries and international organisations, regional and local authorities, representatives of sea and river basins, conservation communities, academia and education, industry, businesses, investors, NGOs and representatives of civil society.
