

## **Prior Information in relation to low value contracts < €60,000**

### **Title: RTD-F-Teambuilding-2013**

This publication is made pursuant to Article 124 of the Rules for Applications of the Financial Regulation that provides for ex ante publication on the Institutions' websites of contracts with a value up to €60 000.

DG Research and Innovation is launching a low value contract in relation to the following subject:  
**"RTD-F-Teambuilding-2013"**

### **Summary**

The Health directorate of the Directorate General for Research and Innovation of the European Commission invites expressions of interest for the organisation of a team-building day, the purpose of which will be to improve our team-working skills. The Directorate supports the research community in pursuit of the goals of improving European and global health, and the competitiveness of European health-related industries and businesses.

The directorate comprises approximately 150 people organised into 6 units and a small team around the Director; staff in 4 units have a scientific background, with the other 2 composed of legal, financial and administrative staff. The staff is diverse in terms of nationality, language and age, and the structure, both organisational and physical, of the workplace can inhibit informal contact and thus reduce effective team-working. The team building event will address this issue. Applicants should demonstrate recent, proven experience of coaching professional groups of appropriate size.

The teambuilding organisation will include organisational/logistical tasks such as catering, transport, provision of technical equipment, but also the coaching of interactive team activities. These activities should preferably include some light exercise/physical activity adapted to a mixed group of people 25-60 years of age.

**Date:** To maximise the impact and to encourage participation of all staff, we would like the event to take place beginning of July 2013.

**Place:** The venue should be located outside Brussels but not too far ( $\leq 30$  km), with convenient access by car and/or public transport. The activities should preferably take place outdoors.

Estimated amount: 30.000 EUR

Estimated launch date: 17/05/2013
