Minutes

Welcome and Introduction

Maria Cristina Russo (European Commission, DG RTD) and Natália Kolibová (Czech Office for Standard, Metrology and Testing) welcomed the meeting participants.

Maria Cristina Russo introduced herself as new Director for Prosperity (Dir. E) in DG RTD. In her introduction, she underscored the critical role of research and innovation (R&I) in Europe's economy, with metrology identified as a key contributor to making R&I more effective. The new EC priorities, including the Clean Industrial Deal and a Circular Economy Act have been mentioned. They aim to retain industries in Europe. Maria Cristina Russo also drawn the attention to three influential reports (Letta, Draghi and Heitor) addressing Europe's industrial challenges and the need for strategic adaptations, increased investments, and competitive scaling of companies within the Single Market. Maria Cristina Russo stressed the need to reflect on the contribution of metrology research in light of these reports and expresses commitment to enhancing metrology's impact on EU competitiveness as a co-chair of the group.

Given the presence of new members in the group. It has been decided to have two informative agenda points on the European Partnership on Metrology (EPM) and the European Metrology Networks (EMN). The meeting agenda was approved. Members have been informed that the minutes of the last meeting have been shared for comments before 15/01/2024. No comments have been received. The minutes have been approved.

Introduction of the new Members and tour de table

Maria Cristina Russo welcomed Dolores del Campo (EURAMET), new chairperson of EURAMET. She replaces Jörn Stenger in the EPM Steering Group who finished his mandate as chairperson. Jörn Stenger has been thanked for his work as member of the EPM Steering Group.

The rotation of the members happening in the EPM Steering Group has been explained. According to the Rules of Procedure of the group (Chapter 2 – Members), a rotation of the members representing European Partnerships and European regulators and standard-setters is foreseen for the mid-term evaluation of the Partnership. In addition to this rotation, one Minna Günes is leaving the EPM Steering Group because she changed job.

The members leaving the group have been thanked for their work and contribution. A warm invitation has been given to them to continue acting as "ambassadors" of the European Partnership on Metrology in the public. The new appointed members have been welcomed and thanked for taking up this duty. Each of the new members had the possibility to introduce him/herself.

The European Partnership on Metrology

Natália Kolibová gave the floor to Jürgen Tiedje (EC DG RTD) for a short introduction on the European Partnership on Metrology (EPM) Steering Group. The group is crucial for guiding the EPM by identifying new trends, technologies, strategic synergies, and industry needs. The Steering Group's responsibilities include providing independent advice on:

- Emerging technologies, innovations, markets, and industrial applications where metrology research could be significant in the future.
- Research areas essential for the single market and the EU's objective of achieving climate neutrality by 2050, including contributions to regulations and standards.
- Setting priorities for future work programmes within the Metrology Partnership.
- Establishing connections with other European Partnerships, Missions, and Initiatives.

The composition of the group reflects this diverse scope, including representatives from EU Partnerships, standard setters, regulators, and the scientific community. Members are expected to contribute their expertise to discussions and serve as ambassadors for the Partnership, promoting its work to other relevant stakeholders.

Natália Kolibová then gave the floor to Maguelonne Chambon (EURAMET/LNE), chair of EPM. Maguelonne Chambon gave an overview of EURAMET and the EPM. The overview included the history of the research programmes on Metrology in the EU, the objectives of the EPM, the description of the two-stage process for the selection of proposals, the plan for the calls from 2021 to 2027 and success stories of projects.

Members have been given the possibility to ask questions. It has been noted that for political reasons, associated states participating in the previous programme under Horizon2020 are not participating in the current EPM. It has been also highlighted the work of EURAMET to organise events to promote the work of the EPM and encourage applicants (especially new ones) to submit proposals.

The European Metrology Networks (EMNs)

Natália Kolibová introduced Hans Arne Frøystein (EURAMET) who is the chair of the Working Group inside EURAMET on the European Metrology Networks (EMNs).

Hans Arne Frøystein presented the work of the European Metrology Networks including their scope and activities. The EMNs are instrumental to bridge the European metrology community to relevant stakeholders in the EU and in the world. In addition to that, they also contribute to the identification of research needs and creation of consortia for project proposals.

Dolores del Campo (EURAMET) updated the meeting participants about new developments in EURAMET, in particular:

Dolores del Campo presented the last draft of the EURAMET White Paper – *Metrology for a stronger Europe*. EPM Steering Group members received the draft

Draft Work Programme 2025 – Presentation of draft calls scopes and Discussion

Maria Cristina Russo opened the discussion by summarising the contribution of the EPM Steering Group to the Work Programme 2025 (WP2025):

- An Orientation Paper has been drafted in the EPM Steering Group. It expresses research needs in areas like radiation, health, quantum, climate and hydrogen as well as manufacturing;
- In the 5th meeting of the EPM Steering Group in March 2024, members have already commented on the draft call scopes for the WP2025.

Mikko Merimaa presented the draft WP2025 which includes the draft call scopes already reviewed by the EPM Steering Group. The EPM Steering Group also received the draft WP2025 for review in advanced of this meeting. Mikko Merimaa summarised all the feedback received by the EPM Steering Group, motivating why each comment has been accepted or not. EURAMET expressed its gratitude to the EPM Steering Group for the valuable feedback on the WP2025.

Maria Cristina Russo thanked Mikko Merimaa and EURAMET for taking into account the feedback of the EPM Steering Group in the new draft WP2025.

EPM Steering Group members have been invited to provide any other potential feedback on the WP2025 by email by 14/11/2025.

EPM Steering Group members have been also invited to provide inputs to the Orientation Paper developed by the group by email by 14/11/2025.

Edoardo Mascalchi (EC DG RTD) suggested to have a fixed agenda points in the next meetings to give the possibility to members of the EPM Steering Group to present their views on potential metrological issues and/or trends in their field of expertise.
