Additional comments

Tables 1 and 2 include EU, EFTA, third countries' contribution as well as C4 and C5 credits together with commitments that can be implemented in 2010 (n+1) or until the end of FP7. When we take into consideration only the credits that may not be carried forward to the next year, the implementation rates reach 99.9% for the commitments and 99.6% for the payments.

Table 6 shows 11461 payments while RTD report shows 23433 because only payments with invoice are included therefore payments to experts are excluded.

Tables 7 and 10 include Recovery Orders of a value of 8MEur to be deducted (1) and show the situation after the DG BUDG corrections.

For contract AIR1-CT92 0511 RO of 1.6MEur have been issued for each of the 6 consortium members, being jointly and severally liable. They all appear in the 2000 figures, although the actual debt is only 1.6MEur. Therefore 8MEur have to be deducted.
