Overview CEI process post second information session Response period now closed

- 18 (out of 57) invited organizations have submitted the statement form
- 11 organisations can be given a clear 'green light' towards next step including next CS3PG. These have committed to 314m€ IKC
 - Notable contributions from TU Delft (100m€), ZeroAvia (65+m€) and TU Braunschweig (25m€)
 - O Israel Aerospace Industries, Siemens, Sonaca and Tecnam propose a contribution of 20 m€ each
- For a further 7 more information would be needed, in particular the nature and scope of IKC. These have committed to a further 27m€, but more may be expected from further enquiry
- No statement form received from 5 organizations (incl. Air Liquide and INTA) who had showed interest following May 20 workshop
