## **Summary**

The directorate comprises approximately 150 people organised into 6 units and a small team around the Director; staff in 4 units have a scientific background, with the other 2 composed of legal, financial and administrative staff. The staff is diverse in terms of nationality, language and age, and the structure, both organisational and physical, of the workplace can inhibit informal contact and thus reduce effective team-working. The team building event will address this issue. Applicants should demonstrate recent, proven experience of coaching professional groups of appropriate size.

The teambuilding organisation will include organisational/logistical tasks such as catering, transport, provision of technical equipment, but also the coaching of interactive team activities. These activities should preferably include some light exercise/physical activity adapted to a mixed group of people 25-60 years of age and be entertaining.

Place: The venue should be located outside Brussels but not too far (≤ 30 km), with convenient

access by car and public transport. The activities should preferably take place outdoors.
