## List of Applicant Cities

Updated on 31 March 2022

On 25 November 2021, the Climate-Neutral and Smart Cities Mission launched a **Call for Expression of Interest** addressed to European cities interested in participating in the Mission. The Call closed on 31 January 2022. Applications, or “Expressions of Interest” (EOI) were received from **377 cities**.

EOIs from **362 cities** have been found to be **eligible**. Cities that submitted **ineligible** EOIs have been informed of their ineligibility<sup>1</sup>. The evaluation of eligible EOIs has now started. The **announcement of results is planned for April 2022**.

Meanwhile, strong interest has been expressed from national authorities, city networks, and from cities themselves to know the names of applicant cities now, i.e., ahead of the selection, to begin to exchange ideas, share information and to begin forming support networks, irrespective of which cities will eventually be selected to participate in the Cities Mission.

Therefore, the European Commission’s Mission team has decided to make the **names of those applying cities** public that (a) have been found **eligible** and (b) have **expressly agreed** to the publication of their name. These cities are listed below, ordered alphabetically by country.

The list does **not include** cities that (a) have been found **ineligible** or (b) have **chosen** not to be made public or (c) have **not responded** to the question about publication of their name.

We will update the list as and when we hear from any of the remaining cities that they are ready to have their names published.

<sup>1</sup> A total of 15 cities were found to be ineligible (either because they did not meet the population thresholds or because they did not include the requisite declaration or letter of support from the mayor).

**IMPORTANT: This is a list of cities that have expressed their interest to participate in the Climate-Neutral and Smart Cities Mission and whose EOIs have been found eligible. This does NOT mean that all of these cities will be selected for participation. The evaluation of the EOIs is ongoing, and the list of selected cities will be published only at the conclusion of the evaluation. The European Commission cannot share any additional information on specific applicants until the evaluations have been concluded.**
